The bidders or their representatives may attend the opening, if they wish so.

4. (i) The firm should have past experience of successfully supplied similar items to any Govt. agency / Govt. undertaking amounting to (two supplies each of value 6 lakh or one supply of value 8 lakh) in last seven years. **(Similar means Supply of bilingual (English & Hindi) software "SARANSH"**
 - (ii) The firm shall have valid registration of service tax/ VAT as applicable, with the State/Central Government. The bidders shall submit PAN / TIN No.
 - (iii) The firm which develops the software or their authorized dealers shall only be eligible for tendering. Authorized dealer/ retailer must submit a copy of memorandum of understanding signed with original inventor.
